108(3) Minutes of the last meeting

Councillors **resolved** to approve as a correct record the minutes of the meetings held on 9 November; 10 November and 29 November 2021.

One member of the public and an invited guest were present. No questions were raised

110(5) Woodland signage

The council received a presentation on the design for the Stalmine Woodland display boards from the person preparing the artwork for the boards. Councillors were asked to consider two options and to decide on a preferred layout to be notified to the February meeting.

111(6) Planning

Councillors noted the decisions made in December under clerk's delegations in conjunction with the planning ambassador:

Application Number: 21/01159/FUL

Proposal: Change of use of land from agricultural to form additional domestic curtilage in association with Moor End Manor and erection of detached garage and annexe.

Location: Moor End Manor Back Lane Stalmine Poulton-Le-Fylde Lancashire.

Objected as of the opinion that the proposal to extend the curtilage is in contravention of CDMD4 and HP5.

Application Number: 21/01378/FUL

Proposal: Erection of stable block for private use.

Location: Land west of New Road Stalmine-With-Staynall FY6 9DT

No objections. Expressed concern at the lack of detail in the preliminary ecology report. It makes no reference to the presence of pink-footed geese or the possible impact on other priority species and the need for important habitats to be preserved.

Proposal: Partial conversion of existing detached garage to ancillary accommodation for use as a hairdressing work area and addition of sliding door/window on north elevation **Location:** 31 Whitebeam Road Stalmine-with-Staynall Poulton-Le-Fylde Lancashire FY6 0FQ

Resolved: The council raised the following objections to this application: the applicant is seeking to move from a class C3 category to an F2 category, this use category has a restriction that there should be no other similar use within 1,000 metres. There is an existing hairdresser on Smithy Lane that is believed to be just within 1,000m, therefore the application should be rejected.

The council was also of the opinion that the development would be contrary to CDMP1 and CDMP3.

Application Number: 21/01355/FUL

Proposal: Single storey-side extension, ground floor and first floor rear extensions and balcony to rear

Location: Bank House Staynall Lane Hambleton Poulton-Le-Fylde Lancashire **Resolved:** The council raised concerns in respect of the proposed balcony which it believed would look directly into the neighbouring property.
